CORPORATE MEMBERS

- Corporate members who wish to appoint corporate representatives instead of a proxy, must deposit
 their original or duly certified of appointment of corporate representative to Tricor Investor & Issuing
 House Services Sdn Bhd ("Tricor") on or before the 7th AGM.
- Attorneys appointed by power of attorney are required to deposit their power of attorney with Tricor not later than Monday, 16 June 2025 at 1.00 p.m. to attend and vote at the 7th AGM.

GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

• Only a depositor whose name appears on the ROD as at 11 June 2025 shall be entitled to attend, speak and vote at the 7th AGM or appoint a proxy/ies to attend and vote on his/her behalf.

REGISTRATION ON THE DAY OF THE 7TH AGM

- Registration will commence at 12.00 p.m. on Wednesday, 18 June 2025 and will remain open until
 the conclusion of the 7th AGM or such time as may be determined by the Chairman of the
 meeting.
- Please present your original National Registration Identity Card (NRIC) or Passport (for non-Malaysian) to the registration staff for verification.
- Upon verification, an identification wristband for voting purposes will be given to you thereafter. No one will be allowed to enter the meeting room without an identification wristband. There will be no replacement for the identification wristband if it is lost or misplaced.
- Registration must be done in person. No one is allowed to register on behalf of another even with the original NRIC or passport of the other person.
- The registration counter will handle verification of identity, registration and revocation of proxy/ies.

Proxy

The appointment of proxy may be made in hard copy form or by electronic form in the following manner and must be received by the Company at least forty-eight (48) hours before the time appointed for holding the 7th AGM or any adjournment thereof, otherwise the Proxy Form shall not be treated as valid:-

Register as a User with TIIH Online	 Using your computer, please access the website at https://tiih.online. Register as a user under the "e-Services Login". Please refer to the tutorial guide posted on the homepage for assistance. If you are already a user with TIIH Online, you are not required to register again. 			
Proceed with submission of Proxy Form	 After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password. Select the corporate event: "Aimflex Berhad 7th AGM - Submission of Proxy Form". Read and agree to the Terms and Conditions and confirm the Declaration. Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf. Appoint your proxy/proxies and insert the required details of your proxy/proxies or appoint the Chairman as your proxy. Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes. Review and confirm your proxy(s) appointment. Print the form of proxy for your record. 			
ii. Steps for corporate or institutional shareholders				
Register as a User with TIIH Online	 Access TIIH Online at https://tiih.online Under e-Services Login, the authorised or nominated representative of the corporate or institutional shareholder selects "Create Account by Representative of Corporate Holder". Complete the registration form and upload the required documents. Registration will be verified, and you will be notified by email within one (1) to two (2) working days. Proceed to activate your account with the temporary password given in the email and re-set your own password. Note: The representative of a corporate or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration.
